BOARD MINUTES

Consideration of Serrano Water District Board Meeting minutes of the regular board meeting of January 24, 203 and February 15, 2023. Director Reese moved that the minutes of the January 24, 2023 and February 15, 2023 meetings be approved as submitted, Director Bryant seconded the motion, and the motion was carried with Directors Bryant, Haight, and Reese voting yes.

GENERAL MANAGER REPORT

General Manager Vilander summarized the status of Board Committee and management matters as agendized for the month of January. Highlights included a review of various meetings attended and current issues. General Manager Vilander gave an update on the State's mercury study that will occur in April at Irvine Lake, water being released at Santiago Reservoir, the C.L. "Larry" Pharris Jr. Filtration Plant, chlorine costs and the cracking study at Santiago Reservoir. Additional ADU's are being constructed in the City of Villa Park. General Manager Vilander delivered an in-depth lobbyist update. All Directors will be attending the visit with Congresswoman Kim Young on 3/31. Director Haight remarked that a listing of all grants being pursued should be presented at the Town Hall meeting.

FINANCIAL REPORT

Business Manager Roggero presented the financials for the month of January. It was moved (Director Mills) seconded (Director Haight), and carried with Directors Bryant, Reese, Haight and Mills voting yes to approve the disbursements in the amount of \$1,143,434.78. Business Manager Roggero distributed the report on salaries that will be given to the State Controller's office. President Reese remarked that he had reviewed the invoices for I.T. Problem Solvers and stated that the charges seemed reasonable.

WATER REPORT

General Manager presented the water report for the month of January and noted that water is being released from Santiago Reservoir. The report was received and filed.

SANTIAGO RESERVOIR PROJECT UPDATE

Following discussion led by General Manager Vilander, it was determined that a Special Board Meeting will be scheduled for March 7, 2023 @ 10:00 a.m. to review further. A potential meeting with East Orange County Water District was also discussed. It was agreed that staff would meet first with a potential secondary meeting scheduled with Director Reese and Mills in attendance.
